DOCUMENTATION OF APPETITE Appetite usually is a good indicator of decline in a hospice patient Avoid documentation of good, fair or poor appetite This cannot be measured Instead give the number of meals that the patient ate per day along with the % of intake of each meal Get down to even describing the meal provided in

• The hospice includes assessment of common co-morbid conditions as part of the initial nursing assessment and review of all prescription, over-the-counter, and herbal medications The assessment includes documentation of which conditions and medications are related to the terminal prognosis

Medicare rules and regulations addressing hospice services require the documentation of sufficient “clinical information and other documentation” to support the certification of individuals as having a terminal illness with a life expectancy of 6 or fewer months, if the illness runs its normal course
